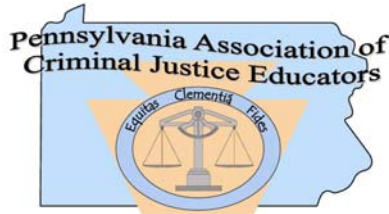

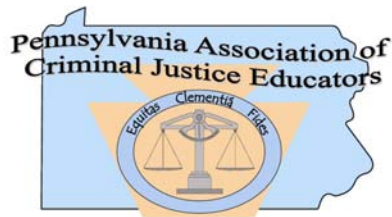

The top undergraduate paper will receive \$50.**

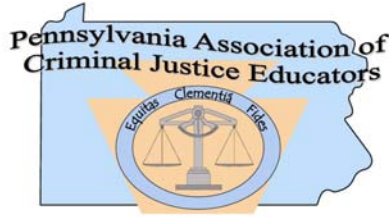

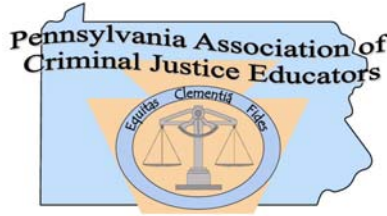
