### **ACA MEMBERSHIP**

In order to enroll in Practicum or Internship, you will need to submit proof of ACA membership as well as liability insurance. Please make sure that both of these documents include your name as well as membership expiration date. You can become an ACA member by going through the steps outlined on their website (www.counseling.org). Many students have inquired about what type of document serves as proof of liability insurance. In order to find this document, please follow these steps:

- 1. Go to the ACA website
- 2. Login using your username and password
- 3. Click on "Evidence of Insurance" which can be found at the bottom of the page
