 - This includes advising them after they graduate as they remain on an F-1 visa for Optional Practical Training (OPT) and STEM OPT

- Prepare and implement programming and events for all international, missionary and third culture students (including the annual International Gala in April)
- Teach GEST 140 "Adjusting to Life in the U.S." to all first-year international, missionary and third-culture students in the Fall semester
- Address developmental needs of international, missionary and third-culture students through individual mentoring, advising and appropriate referrals
- Ensure every international, missionary, and third-culture student has a personal evacuation plan
- Serve as a resource to the Community of Educators as they have questions or concerns about any international, missionary or third-culture student
