Tax Forms and Income Information (all applicants)

If you have not already used the *IRS Data Retrieval Tool (IRS DRT)* to complete the income section of your FAFSA, the best way to verify income is to re-submit your 2015-2016 *FAFSA on the Web* at FAFSA.gov and select the *IRS DRT*. This is available 2 weeks after filing taxes on-line or 6 weeks after filing by hard copy.

If you cannot use *IRS DRT*, submit all 2014 Federal IRS Tax Return Transcripts for you, your parent(s) or your spouse (if married). **(Do not send IRS forms 1040 unless requested.)** You can obtain a transcript, free of charge, by: (1) Get Transcript ONLINE or Get Transcript by MAIL at www.irs.gov/Individuals/Get-Transcript; (2) order by calling 1-800-908-9946; or (3) by requesting a *Transcript of Tax Return* by using Form 4506T (www.irs.gov/pub/irs-pdf/f4506t.pdf). If you did not file a tax return, fill in the information below and submit a copy of your W-2s.

Please note that the Verification process will not be complete until the FAFSA is (re)submitted using the data retrieval function on the FAFSA website or all required Tax Transcripts are received and page 2 is completed.
