

# Messiah College Program Outcomes 2017-2018 Master of Arts in Counseling

#### I. Introduction

The Messiah College Graduate Counseling Program continues to grow and to demonstrate positive outcomes for students and graduates. The program has 9 full time faculty and numerous long term adjunct faculty. The program has a full time administrative assistant, two parttime assistants, and a practicum/internship coordinator. All three Master's tracks offered: Clinical Mental Health Counseling, School Counseling, and Marriage, Couple, and Family Counseling are accredited by CACREP through 2020. Over the past two years the department has undertaken a review and revision of its curriculum in order to align it with the 2016 CACREP Standards. This is in anticipation of submitting a reaccreditation self-study in 2019.

#### II. Mission and Objectives

#### Mission:

Our mission, as a Christ-centered program, is to educate invested and caring individuals who will serve in a variety of settings as counselors characterized by integrity, humility, skillfulness, and understanding. We desire that these professionals will be leaders who facilitate healing, growth, reconciliation and spiritual well-being for diverse peoples.

Program objectives for the graduate counseling program

- 1. To provide students with the specific knowledge and skills required of clinical mental health counselors, school counselors, or marriage, couple and family counselors as delineated by the Council for Accreditation of Counseling and Related Educational Programs (CACREP).
- 2. To prepare students to understand, evaluate and engage in scholarship related to the field of counseling.
- 3. To prepare students to meet the educational requirements for state licensure as a licensed professional counselor (LPC) or as a licensed marriage and family therapist (LMFT), or for certification as an elementary and secondary school counselor.
- 4. To provide the knowledge and skills that enable students to incorporate faith, religion, and spirituality into counseling, and understand how Christian faith connects with the counseling profession.
- 5. To guide students toward an ethical practice of counseling that is grounded in professional and spiritual values.
- 6. To help a diverse student body become self-reflective leaders who understand and address how issues of discrimination, privilege and oppression impact the practice and policies of counseling in a multicultural society.

**C. Geography:** The Counseling Program has students in 31 states. 190 of those are in Pennsylvania. Maryland, New Jersey, and New York have the next most students.

**V. Program Outcomes:** This year was the first year of implementing our new assessment plan that incorporates Messiah's Graduate Learning Outcomes (GLOs) and CACREP standards. See attachment A for the outcomes for 17-18 and action plans to address the outcomes. As a follow-up to our 16-17 results we have put the following changes in place.

- In our research design and statistics course (COUN 545) we strengthened the process in terms of how students get and incorporate feedback on their draft of the literature review. Utilizing feedback on the draft was crucial to improving student performance.

- In our multiculturalism & diversity class (COUN 511) we modified the rubric for the immersion project to place more emphasis on the depth of reflection students were doing on their immersion experiences

- In our Spiritual Formation class (COUN 537) we changed the instructions on the Video Reflection of Immersion Experience assignment so that students would have to address issues of forgiveness and reconciliation as part of their reflections.

#### VI. Survey Data

- **A.** At our departmental retreat in May 2018 we reviewed a number of documents including a year's worth of results from our student exit survey, evaluations of students in Practicum, evaluations of Students in Internship I and II, and field experience site supervisors' evaluation of our counseling program. The following are highlights from each document review:
- Exit Survey Data (see attachment B for actual results): We did not have a very good return rate on our exit surveys so we considered tying them to internship II so that students would be less likely to miss them. We could also send them out through Canvas so that if a student is not checking e-mail they won't miss them. We do feel that we should make separate exit surveys for our master's degree students and our certificate students since their experiences are meant to be different. It is possible we should incentivize the completion of them somehow with a drawing etc. In terms of the results of the survey the following items were noted from the quantitative data:
  - Ratings of advisors were very good, with no responses in the negative range.
  - Ratings of faculty and the internship/practicum coordinator were all positive.
  - Students in all tracks felt they were well prepared to practice in their field, take comprehensive exams, and to pursue relevant licenses or certifications.
  - The knowledge areas the students felt strongest in were helping relationships, connecting Christianity to counseling, ethics, diversity, and the role of the counselor.
  - The knowledge areas students felt weakest in were career development, assessment, research, program evaluation and diagnosis/psychopathology. However most students felt at least moderately knowledgeable in all areas.
  - In terms of skills and duties of a counselor, students felt they were least prepared to conduct counseling research and advocate for oppressed populations. They felt most prepared to create counseling goals, practice competently within their track, write clearly and professionally, and create theoretically-based interventions.

- o All respondents agreed that faith and spirituality were incorporated in their coursework.
- Overall experience with technology and online platforms was positive.
- o 93% of respondents said they would promote the Messiah College graduate program in counseling to others.

Qualitative data (not included in attachment to protect privacy) also revealed the following:

- A theme across what students wanted more of in the curriculum was teaching on specific counseling interventions for specific situations with clients.
- A recommendation that the same faculty supervisor not be assigned for both internships so the student could gain from varying perspectives.
- Some desire to be able to specialize further within a track.
- o Most of the other qualitative comments were idiosyncratic but positive overall.

<u>Evaluations of students in Practicum by site and faculty supervisors.</u> This was a new evaluation tool that was finalized in the Spring and so far has been more user friendly than the previous tool. One area of improvement for students is self-care. Need to make sure we are reviewing these evaluations in remediation meetings to address any character or ethics issues that are noted on evaluations.

Evaluations of students in Internship I by site and faculty supervisors. Ratings on self-care were improved at this level. Fewer ratings of "developing" than the Practicum which is a good indicator of student growth. Still have some problems with the "not applicable" category on evaluation.

Evaluations of students in Internship II by site and faculty supervisors. Problem with students in marriage, couple and family track not getting enough hours with couples and families, particularly if they were at a college counseling center. New standards have been created to ensure that students in this track must be at sites that will give them enough couple and family experience. This is important so they can be evaluated on their skills with couples and families.

Evaluation of program by site field experience supervisors. Overall positive feedback. Main takeaways from reviewing this data is that this tool may need to be revised. Need to make sure we are getting videos of student work in Practicum not just Internships.
