## **Application for an Additional Four-Year Term**

- 1. Submit a summary self-evaluation of the particular scholarship produced during the previous four-year term. Reappointments to the next term will be directly related to the success of the previous term. This summary assessment must provide evidence of meritorious scholarship in accordance to the criteria in the COE Handbook. [See *Community of Educators Handbook* Section 6.16.3.2]:
  - a. Plays a leadership role in appropriate professional societies or organizations.
  - b. Regularly presents papers at professional meetings.
  - c. Contributes to the professional literature in an academic discipline.
  - d. Demonstrates recognized expertise in advanced scholarship and professional involvement through means such as publications, workshops, seminars, testing the application of solutions to real-world problems, consultations, recitals and shows.
- 2. Describe your anticipated scholarship agenda for the next four years, including the scholarly products you intend to produce and a calendar of your proposed activities. The proposed scholarly projects must meet the criteria for meritorious scholarship as approved in the spring of 2015 by the Ranked Faculty Meeting. [See Attachment]:
- A summary of the relationship of the workload reallocation activities and any scholarship
  activities involving a recent reduced teaching load (i.e., scholarship chair, internal grant
  course buyout, external course buyout, or sabbatical) in which the faculty member might
  have been involved.
- 4. Updated curriculum vitae.

Proposals should be submitted electronically to <a href="Provost@messiah.edu">Provost@messiah.edu</a> by October 15. A committee comprised of the Provost and the School Deans will review the proposals and select recipients by November 15. Any appeals to this Committee's decisions are made to the Scholarship and Development Committee whose decision will be final.

## **Scholarly Products and Evaluative Criteria**

The following is a summary of the expectations for meritorious scholarship as recently approved by the Ranked Faculty Meeting in the Spring of 2015. The full document can be viewed on Canvas.

- 1. Scholarly Product:
  - a. Scholarly Product Level 1(lesser significance)
    - Present scholarly work in a low-competition or moderately competitive professional venue or organization related to the discipline
    - Deliver invited address or speech at a low-competition or moderately competitive professional venue
    - Perform or display a scholarly/creative work in a low-competition or moderately competitive audience
    - Publish a discipline-specific work in a low-competition or moderately competitive venue or with publishers utilizing a high acceptance rate for publication
    - Receive a low-competition or moderately competitive, non-Messiah College grant, award, recognition, or honor related to discipline-specific scholarship or practice
    - Serve as a consultant in a discipline-related context where selection indicates a respected reputation in your field (must be accompanied by a written report that could be disseminated to the scholarly community and evaluated for quality)
  - b. Scholarly Product Level 2 (greater significance)
    - Present scholarly work in a highly competitive professional venue or organization related to the discipline
    - Publish discipline-specific work in a highly competitive venue or with publishers utilizing a competitive acceptance rate for publication
    - Perform of display a scholarly/creative work in a highly competitive audience or venue
    - Deliver an invited keynote address at a high-level venue in one's discipline
    - Receive a highly competitive, non-Messiah College grant, award, recognition, or honor related to discipline-specific scholarship or practice
- 2. To be deemed meritorious in the area of scholarship, a term-tenure-track faculty member must demonstrate <u>one</u> of the following over the five- or six-year period of his/her review:
  - a. Regular production of scholarly products in Level 1, i.e., an average of approximately one per year during the review period
  - b. Intermittent production of scholarly products in Level 2, i.e., two or three during the review period
  - c. A combination of scholarly products that would be equivalent to one of the above (a. or b.)
- 3. From a productivity standpoint, some singular scholarly products (e.g., a full-length documentary film or a multi-chapter book) may be equivalent to multiple scholarly products. The Term Tenure and Promotion Committee shall use its judgment in these circumstances, judgment that may be aided by a cogent faculty self-assessment.
