BOARD OF TRUSTEES MANDATE

May 2019

The Board of Trustees authorizes the President and her cabinet to lead an ad hoc task force to conduct a prioritization process resulting in a **reduction of operating expenses by 5 million dollars no later than July 1, 2023**.

The Board reserves the right to **increase the target**, if necessary, and the board encourages the president to continue to lead program innovations that will yield increased enrollment of undergraduate, graduate and post-traditional adult students.



BOARD OF TRUSTEES MANDATE February 2020

In February, the executive committee of the board approved **increasing the FY24 prioritization target to \$7.5 million**.

FY20 COVID-19 FINANCIAL CHALLENGES

The unexpected upheaval created by COVID-19 has quickly and drastically changed our FY20 financial projections, and we now anticipate **an FY20 deficit of \$7 million as a result of unplanned costs**. The following cost containment strategies have been implemented for the remainder of the FY20 fiscal year:

•Operational spending is frozen through June 30, 2020.


- •Unspent capital funding is frozen through June 30, 2020.
- •Temporary furloughs and compensation adjustments across all employee groups and institutional leadership.






EXPENSE DISTRIBUTION

PROJECTED ANNUAL SAVINGS TARGETS FY21-24








ADMINISTRATIVE PRIORITIZATION TASK FORCE GUIDING PRINCIPLE

To generate essential savings while maintaining critical support for the educational mission to our students.

ADMINISTRATIVE PRIORITIZATION TASK FORCE (APTF) RECOMMENDATIONS TOTAL SAVINGS ACHIEVED: \$ 2,628,961

- Eliminate 27 FBE (full-time benefit eligible positions)
- Primarily, these were voluntary (4 involuntary)
- Change a variety of protocols and practices including:
 - Eliminate cable TV
 - Discontinue of cleaning individual campus offices and mail delivery to campus buildings
 - Eliminate some hospitality events
 - Reduce operational budgets and eliminate external communication consultant contract



EDUCATIONAL PRIORITIZATION TASK FORCE GUIDING PRINCIPLE

To effectively fulfill our educational mission by aligning curricular and co-curricular resources with the size and distribution of our current and future student body.

EDUCATIONAL PRIORITIZATION TASK FORCE (EPTF) RECOMMENDATIONS TOTAL SAVINGS ACHIEVED: \$3,464,497 PERSONNEL

- Eliminate 30 FBE (full-time benefit eligible positions)
- Primarily, these were voluntary
- Of the 30 FBE, eliminate 26 FBE in faculty lines, including several involuntary separations. Those identified for involuntary separation will be notified between April 15-May 15.
- Multiple non-faculty positions were reduced, both by voluntary and involuntary separation, and certain positions will be reduced from 12-month to 11-month positions.



(EPTF) RECOMMENDATIONS

PROGRAMMING

- Eliminate six academic majors and three areas of study affecting 12 current students across the six majors.
 - Majors in: Music Business, Art Business and Chinese Business eliminated as distinct majors.
 - Eliminate majors in: Art History, French and Ethnic and Area Studies
 - Eliminate programming in Latin, the German minor and the Academic English Program
- All students currently enrolled in discontinued majors can complete their degrees under a teach-out plan.



(EPTF) RECOMMENDATIONS CURRICULAR

- Revision of the curriculum to reduce curricular need (FTE): focused and streamlined to match student enrollment and enable effective curricular delivery with reduced numbers of faculty.
- Eight departments need extensive curricular revision across one or more program areas in the department. The provost and EPTF will provide data and guidelines for implementation.
- All remaining departments will complete minor to moderate curricular revisions to increase efficiency and align curriculum with current enrollments.



(EPTF) RECOMMENDATIONS

- The hands-on component of Arts QuEST will be replaced with a standard lecture.
- Revision of the enrollment max and overload policy for online courses in the School of Graduate Studies.



(EPTF) RECOMMENDATIONS

CO-CURRICULAR

Reduction in the operating budgets of most areas of the co-curriculum, including athletics.

SCHOOL STRUCTURE REVIEW

The president has authorized a review of the academic school structure to occur in FY21 for implementation in FY22.
 Savings target is \$200,000.



JOINT TASK FORCE GUIDING PRINCIPLE

To be the best employer for a right-sized employee base.



JOINT APTF/EPTF

RECOMMENDATIONS REGARDING EMPLOYEE BENEFITS TOTAL SAVINGS ACHIEVED: \$274,773

We will implement a spousal surcharge (<u>no one</u> will be uninsured). If your spouse has medical coverage at his/her place of employment and you elect to keep your spouse on the Messiah plan, you will pay a monthly surcharge.



JOINT APTF/EPTF

RECOMMENDATIONS REGARDING EMPLOYEE BENEFITS TOTAL SAVINGS ACHIEVED: \$274,773

Long-term savings will result from the following change to tuition remission benefit:

Employees hired **after August 1, 2021** will receive a benefit that includes <u>only</u> two tiers

- Tier one for Messiah (100%) remains unchanged
- Tier two will include all other institutions at 50%

We will continue to devote time, energy and resources to prioritization to achieve **a minimum of \$7.5 million of savings by FY24** – understanding that the target will likely be increased by the board of trustees.



Throughout the summer and FY21 the President's and Provost's Cabinets and Working Group 1 of EPTF will continue to analyze additional cost savings for FY21-24 and that information will be communicated to campus via presidential updates and posted to the prioritization website.








NEW PROGRAMS LAUNCHING

Adult degree program for Aug. 2020:


