**Recipients of the Nursing Student Loan are determined by financial need and availability of funds. Priority will be given to students who have the highest unmet financial need. Since applications usually exceed available funds, applicants will not receive a notification if they are not chosen. You must apply each year and there is no guarantee that if you receive it one year, you will receive it in subsequent years.**

Eligible maximum amounts awarded are as follows:

- \$2,500 for first & second year students
- \$4,000 for third and fourth year students

The regulations of the Nursing Student Loan program require that all recipients go through the Verification process even if they were not selected for verification when they filed their Free Application for Federal Student Aid (FAFSA). Verification is a process whereby you must submit copies of your tax forms to the Financial Aid Office which will then be compared with your application data to verify its accuracy.
