## Introduction

Illegal immigration to the U.S. has been an ongoing issue. This situation is by no means a simple one and will not be satisfied with simple solutions. This research sought to understand the factors causing individuals to come to the States illegally. ### Data

Current data from the National survey of Latinos conducted in March of 2021 reveals that those subject to undergoing the processes of the immigration system agree that it is faulty and ineffective. They agree that the government needs to address immigration reform as a crucial top priority. The challenges faced by immigration courts seem insurmountable as they receive an overwhelming amount of cases and a system unable to process. The lack within the Border patrol system leads some to enter illegally and slip through the cracks as stations are limited in their capacity to conduct proceedings.





# Analysis

In recent years, the efficiency of USCIS and Customs & Border Protection in preventing illegal immigration to the United States has been severely low...This has affected the lives of thousands of immigrants as well as the infrastructure of our country's trust and safety. There are several reasons why the cycle of illegal immigration has been perpetuated. The major reason is the failing system we have in the U.S.The number of immigration cases filed in 2022 were about 700,000. However, judges were able to only complete around 400,000, leaving a backlog of around 300,000. The data reveals that if things continued at this rate, it would take at least 5 years to clear the backlog, even if no additional new cases were accepted. Another factor perpetuating illegal immigration is the limited number of categories individuals can fit under. Many immigrants are ineligible to enter as an asylum, highlyskilled worker, or family relative. The wait time for unskilled labor visas are extreme for those living in destabilized countries.
